Only one run will be made, your qualifier run will automatically be *rolled* into Open 2D Pole Bending. If you qualify for Vegas you will need to be on the arena floor immediately after the round for pictures in dress code.

Timers: Electric timer will be used. Reruns will be given only in the event of a timer malfunction and penalties will be carried over. Reruns will not be given for horses falling, contestant's equipment breaking off for a rider's decision to pull up.

Drags: There will be a tractor drag after every 5 drawn runs and a big drag after every 50 drawn. A big drag will be done prior to the Open 4D and Xtreme Barrels. Each class will start with #1 run. Turn outs and releases will be included in the count. The ground may be reworked at any time at the discretion of The Showdown committee for the safety of everyone.

Disqualification: Contestants must be ready when called. Failure to be in position in the holding area will result in a disqualification. Contestants must be in holding pen during your drag.
